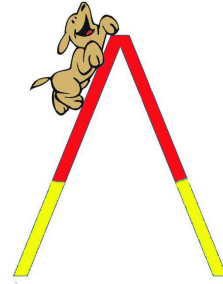

I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury caused or alleged to be caused by negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I hereby assume the sole responsibility for and agree to indemnify and save harmless the aforementioned parties from any and all loss and expenses (including legal) by reason of the liability imposed upon by any of the aforementioned parties for damage causing bodily injuries, including death, at any time resulting from or sustained by any person or persons including myself, or on account of damage to property arising out of or in consequence of my participation in any club event, howsoever such injuries, death or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees, agents or any other person. I agree that the organization has the right to refuse this application for causes that the organization shall deem to be sufficient.
